We have been the "new" part of town on the west edge of the City. However, land for residential subdivisions is close to being built out. Pressure is mounting for development of new land tracts above us to the west.

Development of the upper mesa will change Taylor Ranch. More traffic on our streets is likely as those new residents "pass through" us to get to other parts of town. Our inventory of homes will be older and could be less competitive with newer subdivisions unless we have rigorous property maintenance.

Our next Councilman and Mayor will be key players in determining if, when, where, and how growth will occur on the upper mesa. They will determine when major streets get built; who pays the substantial costs of water and sewer lines and roads; and where land can be rezoned. They will also determine TRNA's level of influence in making those decisions.

ZONING UPDATE

The Trails

(Montano between Pojoaque & Whiteman)

Neighborhood concerns were aired in the September 4th neighborhood meeting. Many thanks to Karee Sowards for hosting the successful meeting of approximately 50 neighbors, Thompson Engineering, and Consensus Planning.

The current site proposal consists of one long street ending in a cul-de-sac next to Kachina. Traffic for the new subdivision will have access only from Montano. A sidewalk will connect to the adjacent neighborhood. This design is desired by most adjacent neighbors. One concern is that it requires cutting a turn lane into the Montano median, reducing the landscaping there. Another is the very long wall along Pojoague and Kachina.

The Development Review Board (DRB) will review this project on September 26 for Preliminary Plat and Grading Plan approval. TRNA wrote to the DRB supporting the current design but asking that the perimeter wall be of brown split face block (for aesthetics and to prevent graffiti) and include some landscaping.

Affected neighbors should keep up their dialogue with Thompson Engineering and the future homebuilder regarding the specifics of the wall, landscaping, and the design and quality of homes built on the site.

Quanz Expansion (SE corner of Eagle Ranch & Paseo del Norte)

Quanz Automotive Services received both approval and praise from the Environmental Planning Commission (EPC) and TRNA for their expansion plans.

The new building will be just south of the existing building on Eagle Ranch Road and will match that architecture. Trees and other landscaping will be planted along Eagle Ranch Road and along both sides of All Saints Road.

Xpress Lube and Automatic Car Wash (East of Montano & South of Oxnard)

Xpress Lube and an automatic car wash received approval but no praise for development on the vacant parcel next to the Texaco station. TRNA and neighbors met with the developers on September 6th, and the EPC reviewed the site plan on September 20th.

The EPC and TRNA both expressed disappointment that this Community Core has developed predominantly automotive services, which do not enhance a community as a synergy of other commercial uses could. TRNA efforts focused on making the best transition from the businesses to the adjacent apartments and homes.

The developers are matching the architecture and landscaping of the adjacent businesses. They desire responsible and clean operations. They agreed to work with city staff to provide more landscaping along the west and south..

The EPC required an outdoor patio on the east side of the site for employee breaks, waiting patrons, and a more pedestrian feel. Concern remains about car dryer noise and about teens congregating in the area late at night. The EPC determined that these were enforcement issues requiring follow-up by the owners and neighbors.

Petroglyph Shadows (Mojave just east of Unser)

Petroglyph Shadows, a 29-lot subdivision just south of Petroglyph Park, is moving ahead with development. The owner, Phil Ward, has submitted Preliminary Plat and Grading Plans to the DRB. The plans include view corridors into Petroglyph Park and other features required by the EPC.

Upcoming EPC Cases

On October 18th, the EPC will review three cases of annexation and the establishment of zoning. The first case involves four parcels along Coors and near Paseo del Norte. The second involves two parcels along Western Trail near Coors. The third involves two parcels generally along Winterhaven and Montano Plaza.

- Walking, biking, and transit use increase.
- *Neighborhoods*, not just residential subdivisions, are built at the urban fringe.
- Older neighborhoods are stabilized and improved so that investments in homes and businesses are protected.
- The people-resources needed to solve local problems are retained in older neighborhoods
- The natural environment is protected and incorporated into new developments through design standards.
- Our built environment becomes more attractive and provides a greater sense of neighborhood and southwestern identity.

Check out the report. The *Planned Growth Strategy* can be viewed on the City Council's web site and copies of the study can be obtained on CD-Rom at the Council office for \$5. Chapter 2 of Part 2 is a good place to start.

From the desk of Lieutenant Perea...

Westside Area Command, Cottonwood Substation

A Taylor Ranch resident recently came across a situation one night and asked how this situation might be handled by others who may have a similar experience. This is a very good question and one that I'm often asked.

Question: Last weekend my neighbors were having quite the argument which woke us up and probably some of the others neighbors. It was clear a dispute of some sort was taking place, possibly a domestic dispute. This went on for a few minutes with one party leaving then coming back. I wasn't sure what was the best course of action--should I have just called 911?

Answer: I always encourage members of our community to get involved when they encounter an incident that doesn't seem right. While I don't recommend jumping in the middle and becoming physically involved, I do suggest they call police if they feel a crime may be occurring.

If a suspicious or unknown situation is taking place but you don't really know what is happening, call the non-emergency number 242-COPS (242-2677). If the situation changes or you get new information and learn a crime is in progress or someone is being injured, call back using the 911 emergency number.

Any time you come across a crime in progress, call police using 911 emergency number and be a good WITNESS. If you don't know the parties involved, document for the police any pertinent information such as descriptions of any vehicles, including license plate numbers, and persons involved.

In the mid 1960's in New York, an incident occurred outside an apartment building where witnesses observed a woman being violently assaulted and stabbed. Her screams went on for some time. Many people heard and observed what was taking place but no one bothered to call the police. The woman died of her stab wounds.

While I don't think the people of Albuquerque would ever let that happen here, it is important to get involved.
