Land Use Update

WTF (Wireless Telecommunications Facilities): On October 11th, EPC held a special hearing for the concealment of WTF (cell phone towers). Last year ,

Councilor Harris sponsored legislation to conceal all cell towers, including existing towers. Since then, the Cell Phone/ Tower Industry representatives and Neighborhood representatives have attended numerous meetings to work on the proposed legislation. At the hearing, Industry wanted fewer restrictions placed on them to conceal all new towers. They claim concealed towers are less efficient than the non-concealed towers. The Planner told the EPC Commissioners that compromises have already been made for the Industry, and that the legislation needs to focus on the concealment of cell towers; which is the purpose of the legislation. The compromise is that existing towers will remain as they are, unconcealed. New cell phone services will either have to collocate onto existing towers or build a new tower that is concealed. Three services can go onto one tower. Neighborhood representatives supported the legislation for the concealment of cell towers. TRNA testified that language from the current regulations should remain strong, as we add on the new legislation. TRNA also didn't want to decrease the current 85-foot tower set back from residential property. TRNA also supported updating the inventory of existing tower locations. The Industry expects that number of cell towers will more than

double in Albuquerque area in order to provide for future services. There will be another special EPC hearing, November 8th.

Vista de La Luz: The EPC approved the commercial/ office development, located on the west side of Coors Blvd. between the San Antonio Arroyo and Sevilla Ave. at its October 18th hearing. The plan had already been deferred twice, because the commercial building, which backed up to Coors, did not contain enough architectural features facing Coors, and did not take advantage of the spectacular views of the mountains. The building also did not comply with building height regulations or provide adequate pedestrian connections to transit stops. A different set of plans was presented at the Oct. 18th EPC hearing. The long commercial building was separated into two buildings. Both buildings still back up to Coors, but each building provides an area with windows and doorways facing the Sandia Mountains. There is now a plaza area between the two buildings, providing a sitting area with a water feature, and viewing opportunities. Two pedestrian connections are now directed from the bus stop at Coors towards the development. This plan is a great improvement over the first two proposals.

West Side Coalition of Neighborhood Assoc.'s Meeting—Oct. 3, 2007

Lovelace West Side Hospital will be having a health fair on October 20, and everyone is invited to attend, should be interesting and informative.

West Side Coalition will be having a new website which will keep everyone informed as to what's going on, more information to follow.

State Representative Tom Anderson indicated that the county was trying to get two new 12 passenger buses, but would not be able to get them before April due to funds will not be available till then.

Bernadette Sanchez indicated that the **Los Volcanos Senior Center** will have a new exercise center, money has been approved.

Ken Sanchez gave an "F" to APS on the School on Wheels program. It was moved onto school property without telling any one about it. Robert Lucero said that West Side wants it, but neighbors don't want it at the grammar school location.

Captain Candelaria indicated that some offenses should be civil suits rather than criminal, such as wild parties, false alarms, etc. These type of calls tie-up officers, when they should be taking care of important cases. The APD is badly understaffed, for instance El Paso has two officers per 1000, ABQ has one officer per 1000. Reason is that APD officers are paid less than any other police force, and constantly lose officers to other cities. It's time our administrators woke and smelled the coffee, and paid our police force in line with other cities.

40% of our crime is committed by repeat offenders, the police catch them, but our judicial system, DA's office and judges have let us down.

Jason Marks, PRC, explained that PNM will be collecting old refrigerators and will offer a \$30.00 rebate to those buying new energy efficient ones. He also indicated that the new CFL lights will save money and environment. You can get more information on www.nmprc.state.us or jasonmarks.com.

Michael Cadigan indicated that at Mariposa Park Basin Park new safety lighting, cameras and more patrols and locked gates after dark are being considered when no games are scheduled. Water conservation is leveling off, due to all the new construction.

Karen Sanchez-Griego will be the new principal for the

new SW High School, which will be devoted to College Prep, with emphasis on the fine arts, including film making. I personally have some questions for APS: why are they only offering college prep, when some students can't make the academy scene? Some students may not want to go college, and offering only college prep courses means they will drop out of school or just be there physically. Why not offer a choice? College prep, Fine arts, or a technical shop course. For the first two years they could do basics and some shop courses, and for the second two years specialize in their choice of College, Art, or Shop/Technical.

Those who choose shop/tech would take courses in electrical, plumbing, carpenter, auto mechanics, etc. so they can be prepared to get jobs in those fields, rather than drop out. This has a proven record in many other cities, such as Chicago.

La Cuentista: On Oct. 18th, the EPC approved an amendment to the Volcano Heights Sector Development Plan, to allow La Cuentista's request for a new medium lot size. Planning staff recommended approval of the amendment to address 60 medium lots, in the La Cuentista development, which is located on top of the Mesa. The Volcano Heights Sector Development Plan had large lot (11,000 sq. feet) and small lot (6,000sq. feet) designations, but did not contain medium size lots (9000sq. ft.). According to Staff, this was an oversight, in which the medium size lots that were already planned by the La Cuentista development were not included in the Volcano Heights Plan.

A separate submittal, by the Volcano Cliffs property owners also contained suggested amendments to the Volcano Heights Plan. Staff recommended a 60 day deferral to allow additional time for the Volcano cliff property owners to draft a reasonable justification of the proposed changes within the context of the City's applicable plans and policies.

According to the staff report and comments taken at the EPC hearing the property owners want the same consideration for their amendments, as La Cuentista. Some of the amendments include increasing the maximum residential building heights to 26 feet, adjusting the development envelopes, subdivide larger lots into smaller lots, change some of the language in the plan regarding conservation easements, and to increase the maximum average density from 3 du/acre to 4du/acre.

TRNA submitted a letter to the EPC prior to the hearing requesting that these amendments don't deviate from the intent of the Volcano Heights plan. We have concerns about traffic, density, and preservation. The Volcano Cliff request was deferred by the EPC.

Coors Corridor Plan: There were two recent articles in the Westside Journal, (one being an editorial), referring to the Coors Corridor Plan Update, in which preserving views was a major component of the plan, in which the residents strongly support. The City is again working on a contract to hire a consultant from Denver to develop view regulations along Coors. This is very promising news.

Harvest Homes: The developer will present their plans to the DRB on November 7th, starting at 9:00am.

Bosquecito: The plan for this project, was withdrawn, by the developer.
